Maguire also tells Conwell of a group of the "most dispossessed men of the congregation" went to Harrisburg in order to procure land that left to Maguire by a Flemish Friar named Theodor Browers. The bill was passed by the House of Representatives, not by the Senate. Maguire wishes to remain at the parish.

- CLB64 To Bishop Conwell from Reverend Timothy O'Brien, 10/02/1827, it concerns a church on the border of the Philadelphia Diocese, which Father O'Brien feels should be administered by Philadelphia priests. The greater portion of the population comes from Lancaster
- CLB63 To Bishop Conwell from "A Lover of the Church of God and not of injustice," no date. It is a derogatory letter to the Bishop, calling him unjust in his handling of certain matters in the Church of Philadelphia. It mentions Hogancism and the Reverend William Hogan, and also the reactions of the Protestant Community
- CLB62 To Bishop Conwell, to Owen McDonald, December 26, 1826, it is a letter concerning the first confession of his son, noting that it is important that the sacrament first be explained to a child before it is received. Also concerns permission to build a church at Ebensburg.

- CLB 59 To Bishop Conwell, from T. Kenny, Coffe Run, PA, 12/06/1826, it concerns Wilmington and the Sunday obligation there. Kenny feels that since a full-time priest is not there, it would not be sinful for the people to miss an occasional Sunday Mass. Kenny concludes by stating that a better solution would be the appointment of a permanent priest

- CLB81 To the Irish Catholics of London and Dublin, from Matthew Carey, 02/28/1837, it concerns his publication of *Vindicine Hibernicae*. It concerns the Irish-Catholic cause, both in America and abroad. Carey is discouraged, since subscribers are few. He believes this is a fine and meaningful publication.
- CLB82 March 23, 1829, a deed selling to Bishop Conwell a piece of ground situated in the borough of Bellefonte. The ground was previously owned by a Mr. and Mrs. Franklin Smith
- CLB83 To Bishop Conwell from Francis Varin, S.J., 07/08/1836, it is a letter thanking Conwell for his spiritual support through the years. Mention is made of his own situation in Little Bohemia
- CLB85 To Henry McKeon from Hugh Sweeney, 06/01/1838, it is a letter requesting a subscription to the authentic report of _____ in the Catholic Herald
- CLB78 To Bishop Conwell, from Francis Varren, S.J., it is a letter thanking Conwell for his support through the years. There is a description of his career as a teacher of French in Virginia. He mentions that he has been forbidden to say Mass by Bishop Kenrick (10/23/1835?)
- CLB86 (also 20.14), to the people of Philadelphia from Pope Pius VII, 08/24/1822, bull of excommunication of Father William Hogan
- CLB87 (also 20.10), to Bishop Conwell from Dimitrios A. Gallitzin, 12/13/1821. It is a letter concerning a married clergyman, asking that he be readmitted into the Church. Mention is also made of Bishop Fenwick of Cincinnati, Ohio who wishes to annex the western part of the Diocese of Philadelphia to that of Ohio
- CLB88 To Reverend J. Keely, Laurel Hill, Pennsylvania, from John Power, 03/12/1835, it speaks of a situation in which Keely is involved and about which Bishop Kenrick has remained close-mouthed. Mentions arrest of John Power.

- CLB57 A sermon on “What Is a Saint” The Author is unknown, possibly Conwell
- CLB92 To Bishop Conwell, from Francis Varin, S.J., of Goshenhoppen, 05/11/1838, it is a letter thanking Conwell for his spiritual support throughout the years and a continuing commentary on Father Varin’s health and situation
- CLB50
- CLB30 To the Clergy of Philadelphia from Francis Patrick Kenrick, 07/30/1831, it furnishes the Clergy with the Decrees of the Provincial Council of Baltimore
- CLB38 It is a copy of some of the decrees of the First Provincial Council of Baltimore under Bishop Egan in 1810
- CLB47 To Reverend Cooper, a Catholic Priest from D. Barber, a priest, Windsor, Vermont, 07/29/1822, there are some insights on Catholicity in the area. There is also mention of Conwell’s visit there

- CLB46 To Bishop Conwell from Francis Varin, S.J., 06/28/1821, he asks advice of Bishop Conwell about the German Church in Baltimore
- CLB45 To Bishop Conwell from Mr. Sullivan, 04/13/1821, Mr. Sullivan, for some unknown reason, must leave Philadelphia for fear of his life. He asks Bishop Conwell to take care of his wife and family.
- CLB44 To Bishop Conwell to Dimitrios A. Gallitzin, 02/09/1821, it is a letter congratulating Conwell on his appointment as Bishop. The letter also warns him of the Trustee situation in Philadelphia. He eludes to the problems of Bishop Egan "who died partly of a broken heart."
- CLB43 To Bishop Conwell to Dimitrios A. Gallitzin, December 12, 1821, Loretto near Munster. Father Gallitzin informs Conwell that he has been nominated Bishop of Detroit. He asks instead that he be appointed a Vicar to Conwell. He would be at the command and disposition of the Bishop to administer Confirmation in the western part of the diocese. He lists reasons why he should not be made a Bishop
- CLB42 To Bishop Conwell to A. MacDonald, May 15, 1821, it is a letter of distress and consolation to Bishop Conwell about the recent events in the Philadelphia Church
- CLB34 To Bishop Conwell to Patrick McNally of Ireland, 04/05/1824, it is a friendly letter
- CLB32 To Bishop Conwell from Thomas Kelly, 06/07/1833, it is a letter reporting of land purchased in Georgia and his intentions to build a church on this land
- CLB 28 These are accounts dealing with an 1823 trip made throughout the East Coast. The author is unknown
- CLB33 It is a copy of a contract stating that Francis Neale has legal rights to St. Joseph's Chapel. However, it is not signed, filled in or sealed
- CLB35 It is a candid exposition of the case of Reverend William Hogan and a brief history of Reverend Hogan; two sides
- CLB37 "Answer to a false friend of the Civil and Religious Liberties of Man," it is a controversial polemic justifying the fight of the Bishop to appoint and remove priests. It deals with St. Mary's Church, Hogancism, and the Trustee controversy
- CLB36 It is a response to a document sent to Rome by the Bishop of Charleston. It states that the Bishops of the Church hold their power by the Divine Right immediate as successors of the Apostles. Reference is made to the code of Bishop England of Charleston. A principle of Democracy in ecclesiastical legislation is mentioned
- CLB39 "A serious answer to a deceitful letter written by a false friend of the Civil and Religious Liberties of Man and addressed to the Roman Catholics of Philadelphia and the United States of America by many and nobody."
- CLB29 To Bishop Conwell from Father Francis Varin, S.J., 10/23/1835, it is a petition. Mention is made of Little Bohemia. Mention is made to the King of Saxony and gratitude to bishop Conwell for past favors; nine sides
- CLB40 Elucidations of the remarks of Richard Henry Bayard on the case of the corporation styled. The Trustees of the Roman Catholic Society worshipping at the Church of St. Mary in the city of Philadelphia; four sides
