- 30.292 To Archbishop Peter Kenrick, from Archbishop Francis Kenrick, 12/08/1861 (probably), publications; Brownson; Archbishop Hughes of New York sent by Secretary of State to Paris and Madrid; army chaplains especially for hospitals (Latin)
- KJ167 A letter of Bishop Kenrick to Miss Mary Clarke, superioress of the Pious Women who live near St. Michael's Church, 10/02/1839, The Bishop requests Miss Clarke to come to his office to explain the fact that they consider themselves a religious community. He asks that she bring any documents she may have to substantiate this
- KJ140 A letter of Bishop Kenrick to the Reverend P. Rafferty of Freeport, near the city of Butler, 01/11/1837, in this letter, the Bishop states that the congregation can transfer the lot to the future Bishop of Pittsburgh. As an alternative, they may transfer it to him, in trust, for the future Bishop of Pittsburgh
- KJ147 A letter of Bishop Kenrick to Reverend Benedict Bayer, 05/07/1837, in this letter, the Bishop states that he can undertake the confessions of the Poor Clare Sisters
- KJ149 A letter of Bishop Kenrick to Reverend A. Winwright, 05/26/1837, in this letter, the Bishop asks Father Wainwright to undertake the care of the Catholics in the North Hampton and Easton districts



- KJ154 A letter of Bishop Kenrick to Bishop-Designate John Hughes, 12/10/1837, this letter concerns the Church of St. John the Evangelist. It deals with the Charter and the designation of the ownership of the church
- KJ161 A letter to Bishop Kenrick to the Pope, 04/20/1839, the Bishop is sending the first volume of his Moral Theology
- KJ162 A letter of Bishop Kenrick to Joseph Bonaparte, 06/06/1839, the Bishop begs him for the picture of St. Mary Magdalen for the Church of St. John
- KJ134 A letter of Bishop Kenrick to Reverend F.M. Masquelet, 06/19/1836, in this letter, Bishop Kenrick states that he gives consent that Father Bayer may take care of the Germans living in Pittsburgh
- KJ128 From Bishop Kenrick to Henry Pratt, 02/09/1836, in this letter, Bishop Kenrick states that he is sending a quarters-rent to Mr. Pratt for his lodgings. The Bishop also states that he is giving him three months notice. The Bishop claims he is in daily expectation of receiving letters which will dissolve his connection with the Diocese of Philadelphia.
- KJ130 A letter of Bishop Kenrick to Matthew Brewer, of Selinsville, Union County, Pennsylvania, 03/01/1836, In this letter, Bishop Kenrick warns Mr. Brewer that the agreement that he has entered with Mr. John Scharff, concerning a lot in Selinsgrove. The agreement involves a lot on the stands an unfinished Catholic Church. This lot is in possession of the Bishop of Philadelphia, dated 04/15/1828. Therefore, Mr. Brewer is warned that this is neither his property nor the property of Mr. Scharff.
- KJ132 A letter of Bishop Kenrick to Reverend F. Steinbacher, 05/19/1836, in this letter, Bishop Kenrick states that after the first of July, the confessions of women in the town of Lebanon cannot be heard outside the confessional. He warns him that the Latin Language is to be used in the burial of the dead. He also warns that hymns or songs from Protestant hymn books or other vulgar or common language is not to be used
- KJ137 A letter to Bishop Kenrick in response to Reverend Benedict Bayer, 12/12/1836, in this letter, Bishop Kenrick states that it may be necessary to give the following public notice from the pulpit. If any opposition be offered to the pastor or the managers of the Church of St. Patrick or any measures be adopted contrary to the regulations, the Bishop shall regard these acts as contrary to his authority. He shall feel released from any arrangement regarding the building now designed for a church for the use of the Germans.
- KJ138 No date, apparently, somewhere in December of 1836, but no recorded date, from Bishop Kenrick to the Trustees of Trinity Church. The bishop states that he is aware of a measure put before the State Legislature by the trustees. He states that it is unlawful for the pastor of Trinity Church to preach in the English language, if ten members of the congregation object. The Bishop strongly asserts the Episcopal authority that neither the Civil legislature nor the Trustees can interfere in the sacred functions of the church.
- KJ139 no date, probably December, 1836, it is a petition of Bishop Kenrick to the Senate and the House of Representatives of the State of Pennsylvania, the petition concerns the preaching in English at Trinity Church. The Bishop requests that the Legislature withdraw this because it is not within their jurisdiction
- NNO Borgess, Reverend Anthony at Mount St. Mary's Seminary in Emmettsburg, from Bishop Kenrick, 02/04/1836

- KL Journal of Bishop Kenrick. Preface: a note from Archbishop James Roosevelt Bailey of Baltimore, 01/07/1874 stating that he is sending this journal from the Baltimore Archives to Archbishop Wood of Philadelphia to be placed in the Philadelphia Archives. The journal covers the years 1830-1851. This is the period that Francis Patrick Kenrick was Bishop of Philadelphia. The First letter in the book and the record of the consecration is in the handwriting of the Reverend John Hughes, later Bishop and first Archbishop of New York
- KJ1 By Father John Hughes at Bardstown, Kentucky to Cardinal Cappellari, Prefect of the Sacred Congregation of the Propagation of the Faith, 06/11/1830, the letter is written in Latin and it describes the consecration of Bishop Kenrick as coadjutor to Bishop Conwell of Philadelphia. After reporting the details of the consecration, Bishop Kenrick goes on to tell of some questions concerning jurisdiction. Also, he deals with the fact that Conwell is rumored to have been reinstated in the government of the diocese. In addition, there is mention that Father Gallitzin doubted Kenrick's jurisdiction. Father Gallitzin was determined to follow Conwell until some higher authority testified as to the change in rule. Kenrick also asks that Father Paul Cullen, the young Irish alumnus of the Propaganda College, be sent over to him. He requests alms, books, and sacred vessels. He mentions his desire to erect a church and cemetery in the diocese. The letter concluded with the attesting of the fact of his consecration by Benedict Flaget, Bishop of Bardstown; Bishop England of Charleston; and Edward Fenwick, Bishop of Cincinnati
- KJ3 Letter from Bishop Kenrick to the Reverend Patrick Duffy, 07/20/1830, the letter states that the Bishop is revoking the faculties of Father Patrick Duffy for reasons that are known to both parties. Evidence is rather clear according to the writing of the Bishop
- KJ4 A letter from Bishop Kenrick to the Reverend Jeremiah Keilley, pastor of St. Mary's Church, 07/23/1830, in the letter, the Bishop forbids the sexton of St. Mary's to officiate in cassock and surplice
- KJ5 A letter from Bishop Kenrick, to Mr. George Daily of Lancaster, Pennsylvania, 08/03/1830, in the letter, Bishop Kenrick requests Mr. Daily to cease litigation between him and his pastor
- KJ6 An excerpt from a letter written by Bishop Kenrick on 08/05/1830 to the Reverend Dimitrios Gallitzin. The Bishop states that Father Gallitzin is free to communicate any evidence to the Reverend Mr. Duffy with regard to the revocation of his faculties
- KJ8 A letter of Bishop Kenrick to Cardinal Cappellari, Prefect of the Sacred Congregation of the Propagation of the Faith. This letter is written in Latin. Bishop Kenrick states the necessity of some clear definition of his jurisdiction be sent over. He makes his request on the basis of the difficulties he is having with Bishop Conwell. There is also mention of Father Hogan and other aspects of the Diocese of Philadelphia
- KJ9 From Bishop Kenrick, to the German Catholic Subscribers of the Memorial, 08/26/1830. This letter concerns the use of the German language of the Holy Trinity. Bishop Kenrick states that the parish of the Holy Trinity was not established solely for the Germans, but rather for the better accommodating people of all languages, particularly the German Catholics. Therefore, he is not willing to approve the memorandum which requests that instructions in the church be given in the German Language.
- KJ10 11/11/1830, directive written to Reverend Mr. Clancey by Bishop Kenrick. Reverend Mr. Clancey is enjoined to visit the various counties of Susquehanna, Luzerne, Columbia, and others to the north of the Schuylkill. He is told by the Bishop to establish a fixed Sunday each month in which he will visit the various congregations, so they will know and be prepared for the arrival of the priest. He is forbidden also to use the English

language in the “rites of the church,” as the Bishop says, “or any innovation no matter how much it is supported by the practice of some individuals.”

- KJ11 11/29/1830, a letter from Bishop Kenrick to the Reverend Peter Kenny, visitor of the Society of Jesus. In the letter, Bishop Kenrick requests information concerning the legal rights of the building at St. Joseph’s. He also states he still does not have a permanent dwelling but only a room. He wants to know if the society has transferred the legal rights to Dr. Conwell for his lifetime, or perpetually, or if it still belongs to the Society. He also mentions here a question of the origin of faculties. Do the Jesuits have any pontifical privilege authorizing them to communicate faculties to their members, in disregard of the authority of the ordinary of the diocese.
- KJ12 12/27/1830, from Bishop Kenrick to the Trustees of the Church of St. Mary’s. The bishop states in the letter that he has the authority from the Apostolic See for the government of the Diocese of Philadelphia, and therefore, he should hereafter act as the chief pastor of the Church of St. Mary’s. He also appointed the Reverend Jeremiah Kelly as assistant pastor
- KJ13 12/28/1830, a letter from Bishop Kenrick to the Trustees of St. Patrick’s and the Building Committee of the Church of St. Paul. The Bishop refuses, for sound reasons, to circulate a written petition throughout the diocese for contributions to the building of the Pittsburgh Church. He also refuses to remove the pastor of the said church and encourages the parishioners to continue working for the building of the church.
- KJ14 A letter of Bishop Kenrick to Reverend Patrick Rafferty, 12/28/1830, this letter concerns the building of the Church of St. Patrick in Pittsburgh
- KJ15 From Bishop Kenrick to the Reverend Samuel Cooper of Wilmington, Delaware, 12/30/1830, the Bishop orders Father Cooper to leave the diocese of Philadelphia and to retire as if it were on his own action – not on that of the Bishop. Otherwise, the Bishop threatens his intervention and authority
- KJ16 There is a note that on 12/31/1830 at 9:00 P.M., three trustees of St. Mary’s visited Bishop Kenrick; namely John Sullivan, Archibald Randall, and William McGlensie. The discussion centered around the appointment of a pastor of St. Mary’s Church. Bishop Kenrick said he was the chief pastor there.
- KJ17 From Bishop Kenrick to Cardinal Cappelari, prefect of the Sacred Congregation of the Propagation of the Faith, 01/07/1831, This letter is in Latin. In it, Bishop Kenrick mentions that he took great care not to do anything that would antagonize Conwell. Bishop Kenrick states that he is still abstaining from using the liberty that the Sacred Congregation gave him, or declaring by public document that he alone had the rule of the diocese.
- KJ18 A letter from Bishop Kenrick to the Reverend Matthew Herard of Baltimor, 01/05/1831. In the letter, the Bishop gives Father Herald all the faculties of the Diocese of Philadelphis and particularly of the direction of the Poor Clare Nuns in Pittsburgh.
- KJ19 A letter from Bishop Kenrick to Father Dimitrios Gallitzin, 01/17/1831, in this letter, Bishop Kenrick gives Father Gallitzen permission to call in Father Terrance McGirr to aid in hearing confessions and in saying Mass in the Church of Loretto. However, he restricts this faculty to simply the parties mentioned.
- KJ20 In an entry for 01/19/1831, the Bishop says he receives \$100 from the Trustees of the German Church in the city. They told him it was for services done to the said Church.

The bishop took acceptance to this statement. He accepted the money and signed the receipt in order to avoid litigation

- KJ21 A letter of Bishop Kenrick to Reverend Michael Curren of Harrisburg, 01/20/1831. Bishop Kenrick asks Father Curren to be on his guard, lest the Trustees of St. Mary's Church seek some charter of the church secretly from the State Senate.
- KJ22 A letter from Bishop Kenrick to reverend John O'Reilly, 01/21/1831, this is a response to a letter from Father O'Reilly requesting the erection of a church in Hollidaysburg. Permission is granted provided there is no difficulty involved with the neighboring parish of Newry.
- KJ23 A letter of Bishop Kenrick in answer to Reverend John J. Kurten, 01/22/1831, in this letter, the Bishop allows Father Kurten to move from the Church of the congregation of Brownsville to Milton in Northumberland County.
- KJ24 Letters given to Mr. Arthur Mallon from Bishop Kenrick, 02/02/1831, Bishop Kenrick says that Mr. Mallon is not considered a malicious calumniator, an accuser of Reverend Mr. Duffy. He is rather a man who is doing his duty as he sees fit.
- KJ25 A response to the Reverend Samuel S. Cooper in New York from Bishop Kenrick, 02/11/1831, Bishop Kenrick tells Father Cooper that he should leave immediately for Europe; otherwise, ecclesiastical censures would be inflicted upon him.
- KJ27 A letter from Bishop Kenrick to the Mayor of the City of Philadelphia, B.W. Richards, 02/18/1831. In this letter, the Bishop requests information concerning a priest he had heard had been arrested, and brought before the Mayor
- KJ28 A letter to James McSherry from Bishop Kenrick, 03/14/1831, in this letter, Bishop Kenrick states the decisions of the community on the judiciary with regard to ecclesiastical property and securities.
- KJ29 A letter in response to the reverend Thomas Heyden of Newry from Bishop Kenrick, 03/21/1831, Bishop Kenrick tells him that if he decided to make Newry his residence and find encouragement to build a church there, he may undertake its building immediately.
- KJ30 A letter of Bishop Kenrick to Jerome Keating, 03/25/1831, Bishop kenrick states that the deed concerning the property of the Church in Manyunk should be handed over to the proper authorities. There is mention of the approaching dedication of the Manyunk Church which would be John the Baptist in Manyunk.
- KJ31 A letter of Bishop Kenrick to Father Jeremiah Keilly, 04/05/1831, In this letter, the Bishop states that in the end of the election of the trustees of St. Mary's, Father Keilly should announce the clerical trustees for the coming year. They are Bishop Kenrick, senior pastor of the Church of St. Mary's and the Reverend General Jeremiah Keilly, Assistant Pastor of St. Mary's. The Office of the Third Clerical Trustee would remain vacant until the appointment of a pastor by the Bishop.
- KJ32 A letter of Bishop Kenrick to Monsignors John Keaf, John Sullivan, Joseph Snyder, Edward Kelly, John McGrath, William McGlinsey, Archibald Randall, and James Furlong, Trustees of St. Mary's, 04/15/1831, in this letter, the Bishop embodies the declaration to be signed and subscribed to by the Lay Trustees of St. Mary's. This is done in order to bring an end to the difficulties in the parish. The Bishop says that if the trustees do not subscribe to this after 12 o'clock Saturday, all sacred functions in the Church of St. Mary's and the burial grounds, will cease

- KJ33 A letter to Bishop Kenrick from Archibald Randall, 04/16/1831, Bishop Kenrick states that he will await the answer of the Lay Trustees all afternoon (which is on Saturday). This response was written 9:10 in the morning.
- KJ34 A letter of Bishop Kenrick to Matthew Carey, Esquire, 04/27/1831, in this letter, Bishop Kenrick states that he has received Mr. Carey's request to act as a mediator in the controversy between the Bishop and the Trustees of St. Mary's. Bishop Kenrick will accept this, provided the rights and authority of the Bishop are upheld.
- KJ35 A letter of Bishop Kenrick to Matthew Carey, Esquire, 04/27/1831, the Bishop states that he refuses to accept the form of acknowledgement of the Trustees of St. Mary's, since it was initiated only by Matthew Carey himself and not by the Trustees.
- KJ36 A letter of Bishop Kenrick to Bishop Joseph Rosati, Bishop of St. Louis, 05/17/1831, in this letter, Bishop Kenrick explains his actions with regard to the faithful of the Church of St. Mary's. He demanded the cessation of all religious services. Bishop Kenrick gives his reasons for this. He also talks about the Church in Philadelphia; particularly with regard to St. Mary's Church. Bishop Kenrick also mentions that Bishop Conwell had been meeting regularly with the Trustees of St. Mary's. He also states that Bishop Conwell was causing some difficulty, possibly scandal, to the Catholics and the Protestants. Bishop Kenrick is also worried about the possibility of opening litigation against him by the Trustees before the Civil Tribunal.
- KJ37 05/21/1831, a letter of Bishop Kendrick to Monsignors John Keaf, Edward Kelly, John McGrath, William McGlinsey, and Archibald Randall, five of the Lay Trustees of St. Mary's Church. In it, the Bishop states that he has received the communication with their signatures. They disclaim all right to interfere in the spiritual concerns of the church. He arranges a meeting for them with the Bishop at 7:00, the evening of next Monday in his room at St. Joseph's
- KJ38 A letter of Bishop Kenrick to Pope Gregory XVI, 05/30/1831, In this letter, Bishop Kenrick explains to him the situation at St. Mary's and the reasons for the interdict.
- KJ39 A letter of Bishop Kenrick to Cardinal Pedicini, Prefect of the Sacred Congregation of the Propagation of the Faith, 05/31/1831. In this letter, Bishop Kenrick outlines reasons for the interdict on St. Mary's Church and Cemetery. He also mentions the fact of the undertaking of a new church – St. John the Evangelist. Bishop Kenrick would like to declare this church the Cathedral Church of the Diocese. He also speaks again of the difficulties of Bishop Conwell.
- KJ40 A letter from Bishop Kenrick to Bishop Conwell, 06/04/1831, Bishop Kenrick indicates to Bishop Conwell that, as a result of the letters received from the Cardinal, Prefect of the Sacred Congregation of the Propagation of the Faith on September 14, 1831. Bishop Kenrick has the fullness of ecclesiastical jurisdiction and all the faculties accompanying this for the diocese of Philadelphia.
- KJ41 Pastoral letter of Bishop Kenrick to the Diocesan Clergy, 06/04/1831, This letter contains the same ideas as the letter to Bishop Conwell; that is, that he has the fullness of Episcopal jurisdiction in the diocese.
- KJ42 From Bishop Kenrick to Archibald Randall, Esquire, 06/08/1831. The Bishop asks Randall to give notice to the Trustees of St. Mary's of a meeting of the Board to be held on Friday, 06/10/1831, at 7:30 in the evening.
- KJ42.1 A letter of Bishop Kenrick to Cardinal Pedicini of the Sacred Congregation of the Propagation of the Faith, 07/01/1831, in this letter, Bishop Kenrick thanks the

congregation for sending him the books and the sacred vessels which he had sought. He mentions that things are pretty tranquil in the diocese, with the exception of Bishop Conwell of Philadelphia, who is still stirring some trouble. Bishop Conwell is acting as the pastor of St. Mary's and is demanding that the priests seek his blessing before they preach. He is still causing some confusion in the diocese.

- KJ43 Mr. Joseph Snyder, Treasurer of the Trustees of St. Mary's from Bishop Kenrick, 07/21/1831, Bishop Kenrick requests Mr. Snyder to pay him his salary from January 1 to July 1.
- KJ44 A letter from Bishop Kenrick to Cardinal Pedicini of the Sacred Congregation of the Propagation of the Faith, 10/14/1831. In this letter, he mentions that he received the Cardinal's letter of July 30, as well as the letter from the Holy Father on the same day. In these letters, jurisdiction was given him and his situation was clearly outlined. He also speaks in this letter of the dwelling at St. Joseph's, where he and Bishop Conwell lived for a while. He also tells of the difficulties he encountered with Conwell there.
- KJ45 To John Arms of Columbia from Bishop Kenrick. 11/11/1831, in this letter, the Bishop states that he cannot conveniently visit Columbia at this time. He is going on visitation to Elizabethtown and Harrisburg in January or February. However, he will get to Columbia later.
- KJ46 A letter of Bishop Kenrick to Cardinal Pedicini, 11/14/1831, in this letter, Bishop Kenrick asks that two young men in his diocese be admitted to the Urban College in Rome. These two young men are of Indian descent.
- KJ47 A letter of Bishop Kenrick written in conjunction with the Bishop of New York, 11/21/1831. The letter deals with the designation of the boundaries of eastern New Jersey and Western New Jersey. There is a request made for the clarification of which counties are under the New Jersey Diocese, and which are under the Philadelphia diocese. Bishop Kenrick suggests that the counties of Sussex, Hunterdon, Burlington, Gloucester, Salem, Cumberland, and Cape May, along with Warren County should go under the Philadelphia Diocese
- KJ48 A letter from Bishop Kenrick to the Reverend G.I. Clancy of Carbondale in Luzerne County, 11/28/1831. In the letter, Bishop Kenrick states that the Diocese of New York is unwilling to accept Father Clancy under its jurisdiction, until he has left Philadelphia and given up his jurisdiction there.
- KJ50 A letter of Bishop Kenrick to Henry Eagle of Maystown, 12/16/1831. Bishop Kenrick acknowledges receipt of Mr. Eagle's letter which described the desolate state of the Elizabethtown congregation. The Bishop indicates his intention to visit Elizabethtown in the month of February.
- KJ51 From Bishop Kenrick to Reverend Patrick Rafferty, 03/14/1832. Bishop Kenrick states that he has sent Father Rafferty an invitation to the Synod. The Bishop also tells of his intention to appoint Father Rafferty pastor of the congregations of Easton and Haycock. Bishop Kenrick will accept no excuses from Father with regard to this appointment
- KJ52 An excerpt from a pastoral letter of Bishop Kenrick, 02/29/1832, in this letter he mentions some of the decrees of the Provincial Council of Baltimore; particularly the one which sanctions a Diocesan Senate in Philadelphia.
- KJ53 A letter of Bishop Kenrick to Cardinal Pedicini, 04/09/1832, the letter mentions Father John Hughes as the source behind the erection of St. John the Evangelist Church. He mentions also that Bishop Conwell is having difficulty seeing and walking. He mentions

the monastery of the Poor Clare Nuns in Pittsburgh and asks some questions concerning their vows.

- KJ54 A letter of Bishop Kenrick, to Bishop Conwell, 05/01/1832. Bishop Kenrick requests Bishop Conwell to turn over to him legal title of a lot next to the cemetery. Bishop Conwell holds the deed for this land. However, this letter was not sent.
- KJ55 A letter of Bishop Kenrick to the Leopoldine Association, 05/17/1832. In the letter, Bishop Kenrick mentions the fact that aid was sent to him by the Leopoldine Association. He states that they tried to encourage him to establish a Diocesan Seminary. The Association had sent him \$4,803. The letter was written in French.
- KJ56 A letter of Bishop Kenrick to Cardinal Pedicini, 06/06/1832, Bishop Kenrick transmits to Cardinal Pedicini the Acts of the First Diocesan Synod of Philadelphia. In this letter, he speaks of reasons for doing away with the Saturday abstinence. Also, he mentions the difficulty in observing this Saturday abstinence. He also states that because of the many immigrants of Spanish and German descent are not used to this; therefore, it would be very difficult for them to observe this. He also mentions that he wishes to build a seminary; however, he doesn't have a rector or a theology professor. He said he did purchase land three miles from Philadelphia.
- KJ57 A letter of Bishop Kenrick to Edward Lake of Silver Lake, Susquehanna County, 06/14/1832. In the letter, Bishop Kenrick states that he gives his consent to the erection of a Church in Silver Lake. The title must be filled out according to his instructions.
- KJ58 A letter of Bishop Kenrick to Reverend Adam Kindelon, 06/30/1856, In this letter, the Bishop tells Father Kindelon to desist from any plans of female or male schools.
- KJ59 From Bishop Kenrick, to Reverend Jeremiah Keilly of St. Mary's, 07/06/1832. In this letter, Bishop Kenrick states that he is anxious to see well-conducted Catholic schools and institutions in the diocese. He therefore wishes success to Mr. Nugent in his efforts to establish a school at St. Mary's. However, he does not wish to be considered connected with it, in so far as the foundation is concerned.
- KJ60 A letter at the request of Dr. Meally, written under his name, to the Reverend Vincent Harold, 07/17/1832. In this letter, Father Harold is told that he cannot return to Philadelphia, unless he has permission of the Holy See
- KJ61 A letter of Bishop Kenrick to Cardinal Pedicini, 09/07/1832, Bishop Kenrick discusses many topics in this letter. He speaks of the Bishop of Cincinnati, who is a coadjutor and he supports his own choice – Reverend Peter Kenny of the Jesuits. He speaks also of the Seminary. He says that he has three students who are taught by Father Francis Guth. He also mentions the boundaries between the sections of New Jersey, which are under New York and Philadelphia jurisdiction. He also mentions the dispensation from the Law of Abstinence for Saturday.
- KJ62 Excerpt from a letter of Bishop Kenrick to Cardinal Pedicini, 09/08/1832. This letter tells of a priest, Thomas Campbell.
- KJ63 A letter from Bishop Kenrick, to Reverend James Kaminsky, 09/27/1832, In it, the Bishop appoints Father Kaminsky to the charge of St. Dennis' congregation, near Kelly's Factory and St. Mary of the Assumption at Pleasant Mills.
- KJ64 A letter from Bishop Kenrick to the Reverend Peter Kenny, and the Society of Jesus, 12/21/1832. The letter deals with the erection of a church in Southwark and the location

of the priests of St. Joseph's. The Bishop requests that the Jesuits convey the property to Bishop Kenrick upon receiving the value of the property.

- KJ66 From Bishop Kenrick to Archibald Randall, 02/07/1833, Bishop Kenrick informs Randall that the Mother Superior of St. Joseph's in Emmitsburg of the Sisters of Charity have arrived in the city with three sisters to staff St. Mary's School. The bishop requests that the Board of Trustees issue a final communication dealing with the arrangements for and the concerns of the sisters; namely the school building, the convent of the sisters and \$50 for each sister, annually.
- KJ67 From Bishop Kenrick to the Reverend N. O'Donnell, 03/13/1833. The letter deals with The Catholic Herald, the newspaper established in the Diocese. The Bishop tells Father O'Donnell that he is to be concerned with the literary end of the paper exclusively. The Reverend John Hughes is to be concerned exclusively with the financial end of the paper.
- KJ68 Letter from Bishop Kenrick to Charles Schwann, Esquire, 04/15/1833, Bishop Kenrick informs Mr. Schwann that he has rented another house. Therefore, the Bishop will be leaving Schwann's house on the seventh of May.
- KJ70 A letter from Bishop Kenrick to the Central Council of the Society of the Propagation of the Faith at Lyons, 11/12/1833, this letter is written in French. Bishop Kenrick describes the number of French-Catholics in Philadelphia and the need for help from the society of Lyons. He bases his need on his desire to build churches, but particularly in the creation of a seminary.
- KJ71 A letter of Bishop Kenrick to Cardinal Pedicini, the Prefect of the Sacred Congregation of the propagation of the Faith. 11/14/1833. The letter is in Latin. The Bishop mentions that he has four young men living in his house, who are being trained in the priesthood. The training is being done by himself and his brother. The latter has recently arrived from Ireland.
- KJ72 A pastoral letter to the priests of the city from Bishop Kenrick, 11/27/1833. Bishop Kenrick warns them about getting involved in arguments concerning religion. He tells them that they should refrain from becoming involved in such arguments, because of the scandal that it can give to the faithful.
- KJ73 A letter of Bishop Kenrick to the Reverend J. Fitzpatrick of Milton, 12/07/1833, Bishop Kenrick informs him of his designation of the Reverend Arthur Wainwright, as the pastor of Pottsville and Tamaqua.
- KJ74 A letter of Bishop Kenrick to Mr. Bernard Connolly and others from the congregation of Pottsville, 12/07/1833. Mr. Connolly and the others asked the Bishop that he restore things to their original state in Pottsville, by not changing Father McCarthy. However, the Bishop gave reasons for his designation of a new pastor.
- KJ75 A letter of Bishop Kenrick to Joseph White, 12/09/1833, Mr. White, along with other non-Catholics, had written to Bishop Kenrick requesting that Father McCarthy not be changed. The Bishop answered that he had designated a pastor. He also stated that Father McCarthy, as a member of the society of Jesus, would continue in his usual capacity in that Society
- KJ76 A letter of Bishop Kenrick to Cardinal Pedicini, 12/17/1833, the Bishop requests a decision on the case of Father Anthony McGlenn of Lancaster, who had entered marriage. The letter also deals with some other priests who are involved in litigation. There is also mention here of the Bishop of Bardstown who requested the Reverend Guido Ignatius



Charbart be designated as his coadjutor. Bishop Kenrick also thanks the Cardinal and the Sacred Congregation for having sent him books for the seminary library

- KJ77 From Bishop Kenrick to the Reverend Patrick O'Neill of Butler County, 01/03/1834, It is a letter indicating that Bishop Kenrick has received, from the Primate of Ireland, charges against the character of Father O'Neill. It is ordered that he desist from celebrating Mass and dispensing the sacraments. The letter is in English and Latin.
- KJ78 Letters to Reverend Drs. Reilley, Masquelet, Gallitzin, and Stillinger from Bishop Kenrick, 01/03/1833, The letters deal with the letter the Bishop received from the Primate of Ireland, as well as the charges made against Father Patrick O'Neill, the Bishop warns the above-mentioned priests to be sure that Father O'Neill does not celebrate Mass or exercise the ministry.
- KJ79 From Francis Patrick Kenrick to John Waters, Secretary to the Trustees of St. Michael's, 01/04/1834, The Bishop indicates that he has just received the draft of the amended charter of St. Michael's. This gives him, the bishop, the right to appoint a lay trustee, when a vacancy occurs.
- KJ80 From Bishop Kenrick to the Reverend Terrance Donaghoe, 01/04/1834, The Bishop enclosed the letter which he sent to Mr. Waters with regard to the trustee situation at St. Michael's
- KJ81 A letter to Mr. J.B. Pelagand in Lyons, France, 01/14/1834, the letter is actually a description of the Diocese of Philadelphia. It is probably one of the finest descriptions of the diocese from that period of time. It is written in French. It occupies eight sides in the journal. It is written in order to elicit support from the Association of the Propagation of the Faith in Lyons, France.
- KJ82 From Bishop Kenrick to the Reverend Patrick O'Neill, 02/24/1834, in response to a letter received from Father O'Neill, Bishop Kenrick is adamant in refusal to accept Father O'Neill into the diocese. The Bishop refers to the letter he received from the Primate of Ireland, stating that Father O'Neill had committed crimes. The Bishop warns Father O'Neill to return to Ireland, in order to clear his name.
- KJ83 From Bishop Kenrick to the signers of the petition regarding the Reverend O'Neill, 02/24/1834, Bishop Kenrick explains his position and the Canon Law of the Church with regard to such situations.
- KJ84 From Bishop Kenrick to the Reverend F.B. Jameson, President of Mt. St. Mary's, 02/25/1834, this letter deals with Bishop Kenrick's order for Reverend Mr. Butler to return to Wilmington – and his apparent refusal to do so.
- KJ85 From Bishop Kenrick to the Monsignors Peter Duffy, Daniel Cole, John Sweeney, John Duffy, Francis McBride, and Patrick Kelly, 02/28/1834, This letter is in response to testimony given by the above mentioned men to the merits of the Reverend O'Neill. However, the Bishop is unable to accept or interfere into the case, since it is out of his hands.
- KJ86 From Bishop Kenrick to Ricardo T. Lloyd of New York, 02/28/1834, Bishop Kenrick says he has no word on Mrs. Lloyd. Therefore, he is unable to help or answer the letter he received from Mr. Lloyd.
- KJ87 From Bishop Kenrick to the Honorable Judge Randall, 04/12/1834, Bishop Kenrick states that he has appointed a third pastor, his brother, The Reverend Peter Richard Kenrick.

His actions are the result of the increased number of people in the congregation of St. Mary's and the increased need for priests to render them service.

- KJ88 A letter of Bishop Kenrick to Reverend John Fitzpatrick, 07/09/1834, This letter designates the Reverend Wainwright as the pastor of the territory of Mauch Chunk, Ketchen, Beaver Meadows. The Bishop adds that Father Fitzgerald will abstain from the celebration of Mass and other sacred functions within Schuylkill and Northhampton counties. However, with the consent of the local pastor, he may partake in these functions.
- KJ89 A letter written to Reverend Englebert Peiscota, from Bishop Kenrick, 07/10/1834, In this letter, the Bishop urges the priest to repent for his crimes. He mentions that he exercising a duty imposed on him by the Archbishop of Vienna.
- KJ90 A response from Bishop Kenrick to the Reverend George A. Carrell, 07/13/1834, In this letter, the Bishop states that he is not able to give permission to use the church of Wilmington for civic celebration, in the death of Lafayette
- KJ91 To Reverend Matthew Lekue of Hanover from Bishop Kenrick, 06/17/1834, in this letter, permission is given for a private oratory for the use of the Sisters of Charity and the faculties to hear their confessions
- KJ94 A letter of Bishop Kenrick to the Reverend Jeremiah Keilly, 09/30/1834, in this letter, the Bishop says that he has no objection to Father Keilly's opening a literary institution on the property he has recently purchased. However, the Bishop wishes that it will be remembered that, at no time, will the Bishop appear connected with this. Father Keilly will be at Liberty to conduct it according to his own plans and it will be his own responsibility
- KJ95 A letter of Bishop Kenrick to Reverend A.J. Van de Weyer, 10/14/1834, in this letter, Bishop Kenrick grants permission to the Bishop of Detroit to arbitrate the case of the convent of the Poor Clare Sisters near Pittsburgh.
- KJ96 A letter of Bishop Kenrick in response to Reverend James Bradley, 10/25/1834. This letter deals with the desire of the Catholics of Johnstown to erect a church. The Bishop Claims that no one has approached him about it. However, Bishop Kenrick recalls to Father Bradley the regulations made at Baltimore concerning the conditions which must be complied with. He mentions also the Newry Church. The Bishop says he will be satisfied with any arrangement agreeable to Father Bradley and the Newry Congregation. They must conform to the general plan which was outlined by the Provincial Council.
- KJ100 A letter of Bishop Kenrick to Reverend Jeremiah Keilly, 12/12/1834, in this letter, Bishop Kenrick refers to a letter of Reverend Mr. Ryder. It is in this letter that mention of the excited state of mind Father Keilly is made. The Bishop had suggested that Father go to Georgetown for a retreat. Father Keilly could not find it convenient to go, at that time, Bishop Kenrick urges the priest to regain the tranquility of his mind. In the meantime, the Bishop says he must withdraw Father Keilly's faculties and forbid him, under penalty of suspension, the exercise of any spiritual functions whatsoever.
- KJ101 A letter of Bishop Kenrick to Reverend Jeremiah Keilly, 12/18/1834, the letter advises Father Keilly to take a retreat and apply for some other diocese. The Bishop justifies this statement by reminding Father that the problems Father had experienced in the Philadelphia Diocese are too wide-spread and too well-known for him to remain in this diocese.

- KJ102 A letter of Bishop Kenrick to Reverend Jeremiah Keilly, 01/14/1835, in this letter, the Bishop states that he is willing to meet with Father Keilly on Monday, at 10:00 and listen to his explanation. The Bishop says that because of previous knowledge, he does not see the possibility of Father Keilly's restoration of faculties.
- KJ108 A letter of Bishop Kenrick in response to a request of Edward Leavy, 05/29/1835. In this letter, the Bishop states that he is not able to grant the request of the Methodists of Lewistown to use the Catholic Church's bell to summon the Methodists to their service.
- KJ109 A letter of Bishop Kenrick to Cardinal Fransini, prefect of the Sacred Congregation, 06/02/1835. In this letter, Bishop Kenrick submits three names as candidates for the coadjutorship of the Diocese of St. Louis. The names are Reverend John Timon, Reverend John Odin, and Reverend Peter Verocghen. Bishop Kenrick prefers Reverend John Timon, as the most qualified for the position of coadjutor.
- KJ110 A letter of Bishop Kenrick to Reverend John O'Reilly, pastor of St. Paul's Church in Pittsburgh, 06/02/1835, in this letter, the Bishop indicates the appointment of managers of the temporal affairs of St. Paul's Church, together with Reverend John Reilly, pastor of the church and president of the Board of Managers.
- KJ111 A letter of Bishop Kenrick to the Editor of the Catholic Telegraph, 06/02/1835. Bishop Kenrick has enclosed \$10 in payment of a debt. He has also placed an order for a catechism in the German language.
- KJ112 A letter of Bishop Kenrick to Monsignors Mulvany, MacShane, and Tierman, members of the Committee of St. Paul's Church in Pittsburgh, 06/02/1835. In this letter, Bishop Kenrick permits the Committee to request the annual contribution of the members of St. Patrick's Church, toward a liquidation of the debts contracted in erecting St. Paul's
- KJ116 A letter of Bishop Kenrick in response to Benedict I. Shipper, 10/17/1835. Bishop Kenrick says that he is ready to receive any information that Mr. Shipper has concerning the moral character of Reverend Francis Guth, the pastor of the Holy Trinity Church.
- KJ118 A letter of Bishop Kenrick to the Reverend Gregory Waibel, Prior of the Abbey of Einsiedlen in Switzerland, 10/23/1835. Bishop Kenrick thanks him for the books.
- KJ119 A letter of Bishop Kenrick to Dr. Nicholas Wirtz de Rudenz of Switzerland, 10/23/1835, Bishop Kenrick thanks the Doctor for books he had given to the seminary.
- KJ120 A letter of Bishop Kenrick to the Reverend Orsini, confessor to the Sisters of the Visitation in Vienna, 10/24/1835, Bishop Kenrick thanks him for books he gave to the library.
- KJ122 A letter of Bishop Kenrick to the Reverend Bernard Keenan of Lancaster, 11/27/1835. In this letter, the Bishop tells him of certain reports and proof of reports he has seen. Because of these reports, Father Keenan is to leave the diocese or he will suffer the ecclesiastical penalty.
- KJ123 A letter of Bishop Kenrick to Henry J. Tammany of Bellefonte, 12/22/1835. The letter deals with the liquidation of a note that belongs to the congregation of Bellefonte
- KJ126 A letter of Bishop Kenrick to the Reverend Anthony Borgess at Mount St. Mary's Seminary in Emmitsburg, Maryland, 02/04/1836, in this letter, Bishop Kenrick receives Father Borgess into his diocese and gives him the care of the congregations at Lewistown, Bellefonte, and Clearfield.
